Fun Day Camp Program at Cantiague Park

We welcome your camper to the Summer Fun Program at Cantiague Park. Please take a few minutes to review this confirmation.

Your attention to this information now will ensure a happy and safe experience this summer.

HOURS:

Camp operates rain or shine from 9 AM to 5 PM. All campers, unless registered for after care, must be picked up no later than 5 PM. Hours for campers registered for before and after care (extra fee) are 8:30 AM to 5:30 PM.

LOCATION:

Within the Cantiague County Park, follow the road into park and bear left at the golf driving range. At the end, bear right at the playground. Campers should be dropped off and picked up at the field/picnic area ahead.

ACTIVITIES:

Some activities require campers to sit on the ground. Please supply your child with something to sit on for these activities.

WEATHER:

The park has shelters we may use in mildly inclement weather. Remember, camp is held outdoors. Please read the back of this document for information on our "Rainy Day Site".

FOOD:

- Lunch with beverage (not milk) in an insulated bag
- Morning snack
- Afternoon snack
- Water Bottle
Water is provided throughout the day

SUPPLIES:

- Sweatshirt or light jacket
- Bathing suit and towel
- Sunscreen product
- Rain gear
- Sun hat
- Day tote for daily needs

DO

- Pack a nutritious lunch
- Label all items with camper's name
- Apply insect repellent before coming to camp
- Wear sneakers and socks

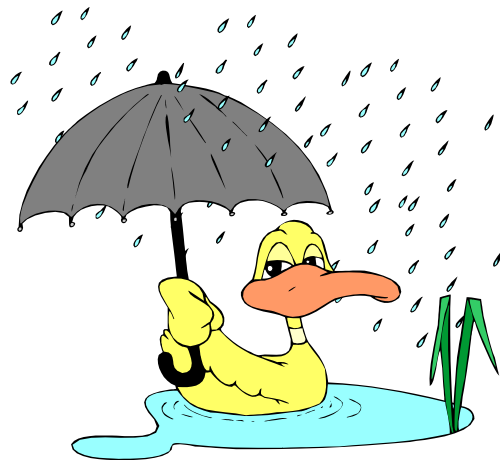
DON'T

- Allow campers to wear bathing suit under her clothes
- Send money to camp. Campers will be notified in advance if money is needed for any reason.

Note: A fully completed Health History form is due by June 1, 2010 and Balance of Camp Fee is due no later than May 1, 2010. Unpaid balances will result in cancellation of your camp reservation.

Directions to Holy Trinity Episcopal Church, 130 Jerusalem Ave, Hicksville

Northern State to Wantagh Pkwy to Old Country Rd East (2nd Old Country Rd Exit – under bridge)

Southern State to Wantagh Pkwy North to Old Country Rd East (1st Old Country Rd Exit)

Approximately two miles to intersection of Jerusalem Ave and Old Country Rd (Wagner Funeral Home on right). Church is on the left side.

Church is on the corner of Old Country Rd & Jerusalem Ave
