**Funding Your Fun!** Your daughter can use any money earned through her Mags&Munchies (Fall Products) and Girl Scout Cookie® Programs to pay for her Girl Scout Troop activities. Here are some ideas:

- Programs and events listed in *Possibilities*
- On-line events listed at the Program Spotlight
- Girl Scout summer day camp or sleep-away camp
- Annual registration fee and Troop dues

The more she earns, the more she can do! In the past, rebates have gone into the Troop treasury and were divided equally among all the girls in the Troop, regardless of their individual achievements.

- You and your daughter decide whether you want her profits pooled with the rest of the Troop, or if you would prefer that they be allocated for her use only. (Funding Your Fun)
- You and your daughter fill in, sign the tear-off below and return it to your Troop Leader whenever you need the funds for a Girl Scout program or event.
- Troop dues and Family Partnership rebates are included in the **“general funds”** needed for Troop operation. The Troop can allocate a percent of Product Sales rebates for general funds as well.

Here is an example of how it works:

- ✓ Your daughter sells 5 magazine subscriptions at \$20 apiece, completes a “Step 2” Address Booklet, and sells \$200 worth of nuts and candies. Under the Funding Your Fun she receives:
  - \$32.00 to the Troop Treasury for her own use plus patches and an incentive prize. (If she opts for no prize, then she would earn \$47.00 plus patches)
- ✓ Your daughter sells 300 boxes of cookies - under Funding Your Fun she receives:
  - \$150 to the Troop Treasury for her own use, \$75 in **Cookie Credits\***, Incentive prize listed on the order card, and theme patch. (If she opts for no prize she would earn \$165)
- ✓ Total earnings for the year for your daughter could be \$212 in the Troop treasury in addition to \$75 in Cookie Credits.

\*Girls in one family who sell 300 boxes of Girl Scout Cookies® receive a \$75 Cookie Credit Gift Card, to be used for any Girl Scout activity. Sisters can combine their sales totals to reach the 300 box level.

**IMPORTANT:** “The income from group money-earning activities never becomes the property of individual members – girls or adults.” Money not used for individual Girl Scout activities remains in the Troop Treasury.
