There are many ways to be a Girl Scout, and Pathways are how we describe all the wonderful options for a girl to participate in Girl Scout activities. Pathways can be combined any way that works for her with the flexibility to explore how Girl Scouting can be part of her life. At her own pace, she can discover herself and the world around her, connect with others and take action to make the world a better place. The Troop is only one Pathway, and she may choose any or all Pathways that suit her interests!

HOW TO GO THE EXTRA MILE WITH YOUR DOLLARS AND YOUR TIME

Most of your registration fee goes directly to GSUSA, but your Family Partnership donation stays in Nassau County and directly benefits your daughter and her Troop. Your donation helps Council develop and maintain programs for the girls, and the Troop may earn a rebate. Donations of \$25.00 to \$39.99 earn a 10% rebate to the Troop, and for donations of \$40.00 or more, the Troop earns a 15% rebate **AND** a special patch for your Girl Scout(s).

Please make **ONE** check payable to your daughter's Troop. This check should include the registration fee(s) and any Family Partnership contribution. **FOR EXAMPLE:**
