Family Campaign: What is it?

Every year *Girl Scouts of Nassau County* asks families to make a contribution to help finance the amazing programs and services that Council brings to girls, volunteers, and local Associations. In order to continue these programs, we need your help.

Family Campaign helps to finance:

- Free Council Patch Programs
- *Possibilities* (Program Guide published and mailed semi-annually)
- *Girlfriends* (Quarterly newsletter of Girl Scouts of Nassau County)
- Financial Assistance
- Specialized Programs such as "First LEGO League Robotics Program"
- Council Trips and Events for girls
- Leader Training and Support

But don't I already donate to Girl Scouts of Nassau County?

The entire \$12 registration fee goes directly to *Girl Scouts of the USA*. Dues go directly to Troops for activities. Money raised from Family Campaign is the only family contribution that goes to support Council programs.

How can my daughter and her Troop benefit?

In addition to the wonderful opportunities listed above, for each Family Campaign donation of \$25 or more, your daughter's Troop will get back 10%. If 10 families donate \$25, your daughter's Troop will have \$25 to spend on patches, books, or any of the other fun and helpful items sold in the Shop!

On the bottom of your daughter's registration form, fill out the box that says: "*I would like to contribute:*" To make it even easier to donate, you can write just one check for both GSUSA registration (\$12) and Family Campaign.
