In the event the Background information raises questions of concern, you will be notified by telephone within 5 business days by a staff member from Girl Scouts of Nassau County.

Performing a Background Check using the Volunteer Portal

Do not upload any document for this background check, simply complete the steps below.

1. **LOG ON** to the Volunteer portal : <https://gsnassauvolunteers.asurint.com/>
2. **ENTER** the **Portal Code** on the Background Check Request Page: **nassauvolunteer** and **CLICK** Continue
3. **REVIEW** welcome information and **CLICK** Begin
4. **COMPLETE** the Applicant Information and **CLICK** Next
6. **READ** Disclosure and Authorization
7. **SIGN:** Using your mouse sign the application in the box provided and **CLICK** Done.
8. **OPTIONAL:** You can skip this step, unless you would also like a second email confirmation sent to a different email address than the one you provided at the start of this process.
9. **CLICK** Submit
10. You will get a message thanking you for completing the process, and you may now exit the program.

The Council Registrar is notified via email that you have completed the process.
